The name of the corporation is PHYSICIAN'S OFFICE MANAGEMENT SERVICES, INC.

The Directors of this corporation may take action by consent, as provided by law.

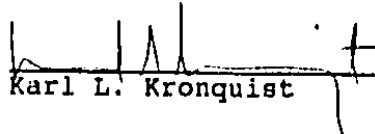
ARTICLE XI

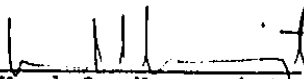
