# ARTICLES OF INCORPORATION OF R.J. INSURANCE, INC.

The undersigned incorporator to these Articles of
Incorporation, a natural person competent to contract, hereby organizes and incorporates a corporation under the laws of the State of Florida.

### ARTICLE I. NAME

The name of the corporation is R.J. Insurance, Inc.

## ARTICLE II. NATURE OF BUSINESS
