ARTICLE I - NAME

The name of this corporation is: I.D.T., SOUTH FLORIDA, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III - PRINCIPAL PLACE OF BUSINESS


election to become a Subchapter S corporation, as such terms are used and defined in the Internal Revenue Code, as amended.

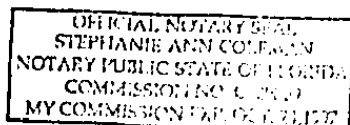
