ARTICLE I - NAME

The name of this Corporation is BINWEAL RACING, INC. and the address is 34151 Parkview Avenue, Eustis, Florida 32726.

ARTICLE II - TERM OF EXISTENCE

This Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS
