ARTICLES OF INCORPORATION

The undersigned subscribers, hereby associate themselves together to form a corporation for profit under the laws of the STATE OF FLORIDA: and hereby adopt the following ARTICLES OF INCORPORATION.

ARTICLE I

The name of this Corporation shall be: SOUTH FLORIDA INSTITUTE OF PHYSICAL MEDICINE, INC., and it's business shall be carried on in BROWARD COUNTY, FLORIDA, and also within and without the STATE OF FLORIDA, and in the UNITED STATES OF AMERICA and FOREIGN COUNTRIES as may from time to time be deemed desirable or expedient.

ARTICLE II TERM OF EXISTENCE


