ARTICLES OF INCORPORATION OF ART GILES, P.A.

The undersigned natural persons, each of whom is licensed or otherwise legally authorized to practice the profession of real estate or perform the service of a real estate in the State of Florida, hereby associate themselves with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopt the following articles of incorporation for such corporation:
