ARTICLES OF INCORPORATION 95 MAR 21 FR 11 32 OR SECRETARY OF STATE LEASING ASSOCIATES INC.

WE, the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to these Articles of Incorporation.

ARTICLE 1

The name of the corporation shall be LEASING ASSOCIATES INC.

ARTICLE 11

The purposes and general nature of the business to be conducted and transacted by the corporation shall be as follows:

- A. To do and transact any and all business as permitted under the laws of the state of Florida and the United States of America.
- B. To engage in the Leasing, Selling, Importing and Exporting of Machinery and Equipment.
 - C. To Lease and Sell Motor Vehicles.
 - D. To Lease and sell Furniture and Fixtures.
- E. To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, or other negotiable instruments, including bonds, debentures, or other obligations of this corporation, whether secured by mortgage pledge, or otherwise, or unsecured, for money burrowed, or in payment for property purchased or acquired, or for other lawful objects.
