The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

VACATION GOLF SCHOOLS, INC.

The address of the principal office of this corporation shall be 2610 Northwest 43rd Street, Suite 1D, Gainesville, Florida, 32606 and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

ARTICLE III. CAPITAL STOCK
