C) To erest, construct, maintain, improve, rebuild; enlarge, alter, manage, and control directly or through ownership of stock in any corporation, any and all kinds of buildinge, houses, hotels, bungalows, stores, offices, warehouses, mill, shops, factories, machinery and plants, and any and all structures and erections which may at any time necessary, useful, or advantageous in the judgment of the Board of Directors, for the purpose of the Corporation, and which can lawfully be done.
