**ARTICLES OF INCORPORATION
OF
DIVERSIFIED MANUFACTURING, INC.**

The undersigned, acting as incorporators of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

1. Name. The name of the corporation is **DIVERSIFIED MANUFACTURING, INC.**

2. Street Address of the Initial Principal Office. 7 1 0
Holsberry Place, Pensacola, Florida 32534.

3. The number of shares the corporation is authorized to issue. One Thousand (1,000) Shares.

4. Preemptive Rights. Each shareholder of this corporation shall have the first right to purchase shares of any class, kind, or series of stock in this corporation that may from time to time be issued, including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the price, terms, and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waivers submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
