ARTICLES OF INCORPORATION

OF

GREENWOOD McDONALD SUPPLY COMPANY OF FLORIDA, INC.

The undersigned subscriber to these articles of Incorporation, being a natural person to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is GREENWOOD McDONALD SUPPLY COMPANY OF FLORIDA, INC., and the principal office of the corporation shall be 1910 Northwest 44th Street, Pompano Beach, Florida 33064.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which shall be designated "Common Shares".


