ARTICLES OF INCORPORATION

OF

I, the undersigned natural person of the age of twentyone years or more, acting as incorporator of a corporation under
the laws of the State of Florida, adopt the following Articles of
Incorporation for such corporation.

ARTICLE I

NAME
