**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of this Corporation shall be: **LEASEKING OF AMERICA, INC.**

**ARTICLE II**

The general nature of the business to be transacted by this Corporation shall be:

The leasing of all types of equipment.

To conduct business in, have one or more offices in, and buy, hold, mortgage, sell convey, lease or otherwise dispose of real and personal property, including franchise, patents, copyrights, trademarks, mortgages and licenses in the State of Florida and in all other states and counties;

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebtedness as required;

To purchase the corporate assets of any other corporation and engage in the same or other character of business;

To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, deal in and with goods, wares, merchandise, real and personal property, and services, of every class and kind.

**ARTICLE III**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Hundred Shares (100) of common stock with a par value of One Dollar (\$1.00) per share. The actual consideration to be paid for each share shall be fixed by the Stockholders.

#### **ARTICLE IV**

**This corporation is to exist perpetually.**

#### **ARTICLE V**

**The initial post office address of the principal office of this corporation in the State of Florida shall be 3031 N. Ocean Boulevard, Suite #202, Fort Lauderdale, Florida 33308, and this corporation's mailing address shall be 3031 N. Ocean Boulevard, Suite #202, Fort Lauderdale, Florida 33308. The Stockholders may, from time to time, move the principal office to any other business in the State of Florida. The Registered Agent shall be: Paula A. Vashey, 3031 N. Ocean Boulevard, Suite #202, Fort Lauderdale, Florida 33308.**

#### **ARTICLE VI**

**The corporation shall not have a Board of Directors, rather it shall be governed by its Stockholders.**

#### **ARTICLE VIII**

**These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved at a Stockholders' meeting by a majority of the stock entitled to vote therein.**

#### **ARTICLE IX**

**No contract or other transaction between the corporation and any other corporation, and no act of the corporation, shall in any way be affected or invalidated by the fact that any of the shareholders of the corporation are pecuniarily or otherwise interested in, or are shareholders, directors or officers of, such other corporation. Any shareholder individually, or any firm of which any shareholder may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction, of the corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the shareholders or a majority thereof, and any shareholder of the corporation who is also a director or an officer of such other corporation, or**


who is so interested, may be counted in determining the existence of a quorum at any shareholder's meeting of the corporation which shall authorize any such contract or transaction, with like force and effect as if he were not such a shareholder, director or officer of such other corporation, or not so interested.

### **ARTICLE X**

The corporation shall indemnify its officers to the fullest extent permitted by law either now or hereafter.

I, the undersigned, being the original incorporator of the foregoing corporation, do hereby certify that the foregoing constitutes the proposed Articles of Incorporation of said corporation.



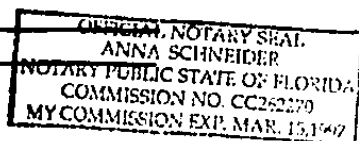


