The undersigned subscribes to these Articles of Incorporation, natural person, competent to contract, deals hereby form a comporation for prefit under the laws of the State of Florida. Corporate existence shall begin upon asseptance of these Articles. This corporation is to be a Small Business Corporation as defined in Section 1244 Subdivision (a)(2) of the Internal Revenue Code.
