ARTICLES I

NAME

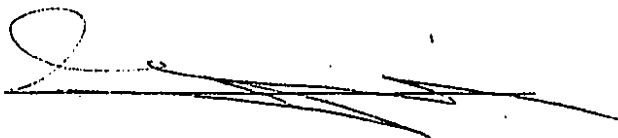
