ARTICLES OF INCORPORATION
OF
MEDITERRANEAN MARKET, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be MEDITERRANEAN MARKET, INC.

ARTICLE TWO: DURATION: The term of existence of the corporation is perpetual.

ARTICLE THREE: PURPOSE: The purpose is to engage in any activities or business permitted under the Laws of the United States and Florida; including, but not limited to, the operation of a grocery business.

ARTICLE FOUR: CAPITAL STOCK: The corporation is authorized to issue one hundred (100) shares, all of which shall be common shares, no par value.

ARTICLE FIVE: INITIAL REGISTERED OFFICE AND AGENT:

DESIGNATION OF REGISTERED OFFICE AND REGISTERED AGENT


Pursuant to Chapters 48.091 and 607.0501, Florida Statutes, the following is submitted:
