1. <u>NAME OF CORFORATION AND INITIAL ADDRESS</u>: The name of this corporation shall be MI-CAR COMPANY, INC., and the initial corporate address shall be 347 W. 14th Street, Panama City, Florida 32401.

2. <u>TERM OF EXISTENCE</u>: This corporation shall exist perpetually unless dissolved according to law.
