The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, forms a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation is RICHARDSON LAW OFFICES, P. A.

**ARTICLE II. NATURE OF BUSINESS**

The nature of the business is for the practice of law and for any other lawful business permitted under the laws of the State of Florida.

**Article III. CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock having a nominal par value of One Dollar (\$1.00) per share.

**ARTICLE IV. INITIAL CAPITAL**

The amount of capital with which this corporation will begin business is Five Hundred Dollars (\$500.00).


#### **ARTICLE X. AMENDMENT**
