

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is TEK ENTERPRISES, INC.

ARTICLE II. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE IV. NATURE OF BUSINESS

This corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act; and specifically, to engage in business relating to properties.

ARTICLE V. CAPITAL STOCK

The aggregate number of shares of stock which this corporation shall have authority to issue is Five Hundred Thousand (500,000), common stock, with a par value set at one dollar (\$1.00).

ARTICLE VI. INTERNAL AFFAIRS PROVISIONS

The provisions for the regulation of the internal affairs of this corporation are all activities allowed under Florida Corporate Law.

ARTICLE VII. PRINCIPAL OFFICE/REGISTERED OFFICE/AGENT




