ROBERT G. SYFORD INC.

I, THE UNDERSIGNED, a natural person of legal age, acting as incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

ARTICLE ONE

The name of the corporation is ROBERT G. SYFORD INC.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is to provde assistance in daily living to the elderly and to provide a livery service of deceased persons to the general public and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is 100 shares of common stock having no par value or amount of par value each.

ARTICLE FIVE
