### ARTICLES OF INCORPORATION OF AMELIA EXCURSIONS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby under the laws of the State of FLORIDA.

#### ARTICLE I -- Name

The mane of the corporation shall be AMELIA EXCURSIONS, INC.

ARTICLE II -- Nature of Business
This corporation may engage in or transact any and all lawful activities or business permitted under the laws of The United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III -- Capital Stock
The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock, having a par value of \$1.00 per share.

ARTICLE IV--Address

Any director of the corporations vote upon any transaction with the corporations regards the fact that he is also a director of such subsidiary or corporation.

This corporation shall have a minimum of one director. The initial Board of Directors shall consist of : David E. Stevenson Tia L. Stevenson
