**ARTICLES OF INCORPORATION  
OF  
CHARLAND CONSULTING SERVICES, INC.**

**ARTICLE I - NAME**

The name of this Corporation is CHARLAND CONSULTING SERVICES, INC.

**ARTICLE II - DURATION**

The corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and Florida.
