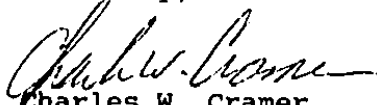

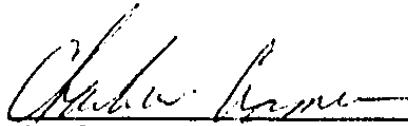

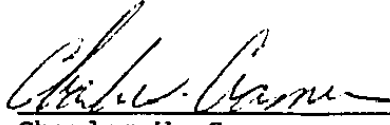
**ARTICLE VI: DATES OF EXISTENCE**
