 OF**

The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is Medical Insurance Training Consultants, Inc. (the "Corporation").
- SECOND:** The principal office address and mailing address of the Corporation is 6171 N.W. 77th Terrace, Parkland, Florida 33067.
- THIRD:** The Corporation is authorized to issue 10,000 shares of common stock, par value \$.001 per share.

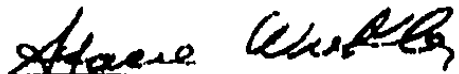
