**Article I  
NAME**

The name of this Corporation is The Healing Institute, Inc..

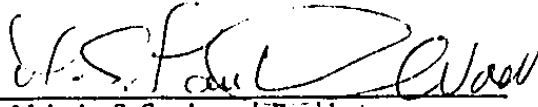
Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:
