

ARTICLES OF INCORPORATION:

- 1.-A corporation is established under the U.S. Code and the Statutes of the State of Florida under the following name:  
CARING AND SHARING FOR PROFIT, INC.  
this shall be a FOR PROFIT SMALL CORPORATION, with less than 30 employees, under Florida Statutes, with the main purpose of providing information, access to ad media, financial counseling and other services for business purposes and to sell mid-size durable goods, many below normal retail, to business people.


