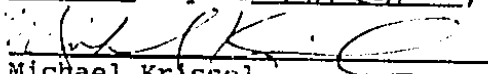
ARTICLE IX

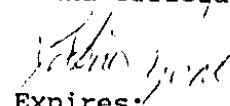

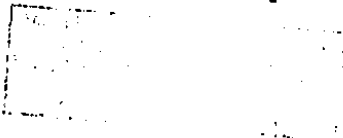

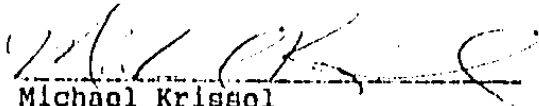
