ARTICLES OF INCORPORATION
OF
PARRISH CENTRAL, Inc.

ARTICLE I. CORPORATE NAME.

The name of this corporation is PARRISH CENTRAL, Inc.

ARTICLE II. ADDRESS OF PRINCIPAL OFFICE.

The address of the principal office of this corporation is 2606 NE 17th Terr., Gainesville, FL 32609.

ARTICLE III. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK.

The total number of shares of capital stock which the corporation shall have the authority to issue is as follows:

- (a) 500 shares of voting common stock having a par value of \$1.00 each share.
- (b) 500 shares of non-voting common stock having a par value of \$1.00 per share.

ARTICLE V. TERM OF EXISTENCE.

This corporation shall have perpetual existence commencing upon filing of these articles.

ARTICLE VI. REGISTERED AGENT AND INITIAL REGISTERED OFFICE.

ARTICLE VII. BOARD OF DIRECTORS.

This Corporation shall have one (1) directors initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the stockholders, but shall never be less than one.

ARTICLE X. AMENDMENT.

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE XI. BYLAWS.

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE XII. RESTRICTIONS ON TRANSFER OF STOCK.

Shares of all classes of stock may not be resold or otherwise transferred to other persons unless first offered to the remaining shareholders or to the corporation. The price and terms of which, and the time within which, those shares may be offered and sold shall be further specified by written agreement among all of the shareholders and this corporation.

ARTICLE XIII. STOCK ENDORSEMENT.


Each share of stock issued in this corporation shall be endorsed as follows:

ARTICLE XIV. INDEMNIFICATION.


The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
