ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is: Mapanu Corporation

The principal place of business is:

731 Washington Avenue, Miami Beach, Florida 33139.

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE
