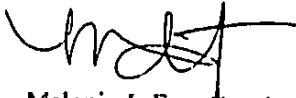

I, the undersigned, natural person competent to contract, do hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

**ARTICLE I
NAME OF CORPORATION**

The name of the corporation shall be:

**ARTICLE II
GENERAL NATURE OF BUSINESS**

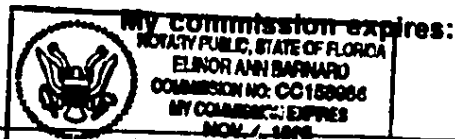
