ARTICLE I - NAME

The name of the Corporation is 931 MHS PAGING CORP.

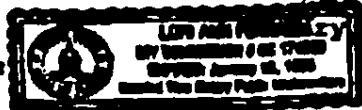

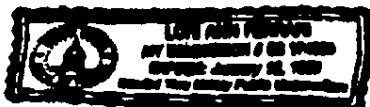
