**ARTICLES OF INCORPORATION  
OF**

**SUNCOAST PARALEGAL OF NEW PORT RICHEY, INC.**

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is **SUNCOAST PARALEGAL OF NEW PORT RICHEY, INC.**, and its principal place of business shall be located at 2533-209 Dolly Bay Drive, Palm Harbor, Florida 34684.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
