The undersigned subscribers to these articles of incorporation, each a natural person competent to contract hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is Whatley's Lawn Service, Inc. The corporation's principal office will be located at: **4350 N.W. 187th Street, Miami, Florida 33054.**

ARTICLE II

The corporation may engage in lawn and tree service. Also, any other activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

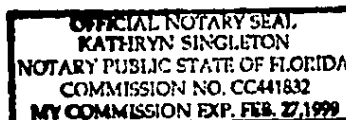
