The undersigned subscriber to theses Articles of Incorporation, being duly licensed to practice law under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I.

The name of the professional service corporation is DUDLEY D. ALLEN P.A.

ARTICLE II.

The principal office and mailing address of this corporation are 112 West Adams Street, Suite 1700, Jacksonville, Florida 32202.

ARTICLE III.

The professional service corporation is formed to engage in every phase and aspect of the practice of law. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE IV.

The professional service corporation shall have perpetual existence starting on the date these Articles of Incorporation are filed with the Florida Department of State.

ARTICLE V.

The capital stock of the professional service corporation shall be 100 shares of common stock without par value.




