ARTICLES OF INCORPORATION

of

PROGRESSIVE HOMES OF VOLUSIA, INC.

The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is

PROGRESSIVE HOMES OF VOLUSIA, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on March 21, 1995.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of No Par Value voting common stock which shall be designated "Voting Common Stock".

ARTICLE V - PRE-EMPTIVE RIGHTS


