ARTICLES OF INCORPORATION

OF

EMPIRE VENTURES INTERNATIONAL, INC

The undersigned incorporator hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE 1 - NAME OF CORPORATION

The name of the corporation is EMPIRE VENTURES INTERNATIONAL, INC

The address of the principal office of this corporation shall be 58 South Ivanhoe Blvd., P.O. Box 540873, Orlando, Fl 32854-0873.

ARTICLE II - TERM OF EXISTENCE
