ARTICLES OF INCORPORATION

0F

FIRST GARDENS, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I Name and Address

The name of the Corporation shall be FIRST GARDENS, INC. and its mailing address is P.O. Box 1, Cypress Gardens, Florida 33884.

ARTICLE II Purpose and Powers

Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.

Section 2. The Corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.

ARTICLE III Term of Existence

The Corporation shall have perpetual existence.

ARTICLE IV Capital Stock

The authorized capital stock of the Corporation shall be 10,000 shares of common stock having a par value of \$.10 per share.

ARTICLE V Board of Directors
