The undersigned, for the purpose of forming a for profit corporation under the provisions of Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I
NAME AND MAILING ADDRESS**

The name of the Corporation is DIGITAL RECOVERY SYSTEMS, INC.
The mailing address for the corporation is 833 Southwest 179th Avenue,
Pembroke Pines, Florida 33029.

**ARTICLE II
TERM OF EXISTENCE**

The existence of the corporation shall begin upon the filing of the Articles by the Secretary of State and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE III
PURPOSE**

The general purpose for which the corporation is organized is for collection services and for the transacting of any business for which corporations may be incorporated under Chapter 607 of the Florida Statutes and any amendments or successor statutes thereto.

ARTICLE IV AUTHORIZED SHARES

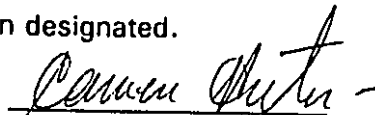


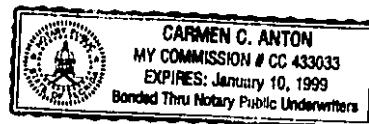
