ARTICLES OF INCORPORATION
OF
THOMAS C. DENSLOW, P.A.

THE UNDERSIGNED natural person who is licensed or otherwise legally authorized to practice the profession of architecture in the State of Florida hereby forms a Professional Corporation in accordance with the Florida Professional Service Corporation Act and hereby adopts the following Articles Of Incorporation for such Corporation.

ARTICLE I - NAME

THE NAME of the Corporation shall be **THOMAS C. DENSLOW, P.A.**

ARTICLE II - PURPOSE

THE PURPOSE of the Corporation is to engage in the practice of architecture as a professional architectural corporation in accordance with Chapter 621, Florida Statutes, and to carry on services incident thereto. The practice of architecture is the sole and exclusive professional service to be rendered by the Corporation.

PROFESSIONAL SERVICES of the Corporation shall be carried out only through its officers, employees and agents; each of whom has been authorized to practice architecture in the State of Florida.

THE CORPORATION is authorized to own property, enter into contracts, to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of the Corporation.

ARTICLE III - CAPITAL STOCK

THE TOTAL number of shares of capital stock which the Corporation shall be authorized to issue One Thousand (1,000) shares. Such shares shall be of a single class of common stock and shall have a par value of One & 00/100 Dollars (\$1.00) per share.

ARTICLE IV - CAPITALIZATION

THE AMOUNT of capital with which the Corporation will begin to practice the profession of architecture is not less than Five Hundred & 00/100 Dollars (\$500.00).

ARTICLE V - DURATION

THE CORPORATION shall have perpetual existence.

ARTICLE VI - PRINCIPAL OFFICE

THE INITIAL street address of the Corporation's principal place of business is 2813 Riverview Boulevard, Bradenton, Florida 34205.

ARTICLE VII - SUBSCRIBERS TO SHARES

ARTICLE IX - DISSOLUTION

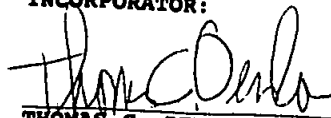
THE CORPORATION may be dissolved at any time in accordance with the following:

UPON DISSOLUTION, the Corporate property and assets shall, after payment of all debts of the Corporation, be distributed to the Shareholders, pro rata, each Shareholder to participate in the distribution in direct proportion to the number of shares held by him or her.

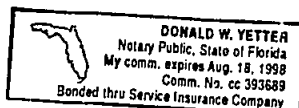

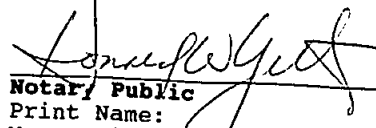

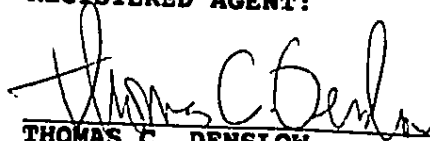
