ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Act hereby adopt the following Articles of Corporation.

ARTICLE I

NAME

The name of the Corporation shall be: Florida Custom Landscapes, Inc.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business and the objects and purposes to be transacted and carried on are: To do any and all legal business allowed by the laws of the State of Florida and of the United States.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding is: 5,000 shares of common stock,

INFORMAL SHAREHOLDER ACTIONS

Any action of the shareholders may be taken without a meeting if consent in writing, setting forth the action so taken shall be signed by all the persons who would be entitled to vote upon such action as a meeting and filed with the secretary of corporation as part of the corporate records.

ARTICLE XIV

PRE-EMPTIVE RIGHTS
