I, the undersigned natural person competent to contract acting as incorporator of a corporation for profit under the General Corporation Law of the State of Florida, do hereby make, subscribe, acknowledge and file the following Articles of Incorporation for such corporation.

ARTICLE I
NAME

The name of the corporation is: GUATE LINDA CORP.

ARTICLE II
GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted is:

To engage in any activity or business permitted under the laws of the United States and of the State of Florida, and any other jurisdiction wherein it may conduct business..

ARTICLE III
CAPITAL STOCK

The amount of authorized capital stock is One Hundred Dollars (\$100.00), consisting of one hundred (100) shares of common stock, having a par value of One Dollar (\$1.00), per share.

ARTICLE IV
PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of any kind, class or series, shall have the preemptive right to purchase his prorata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered.

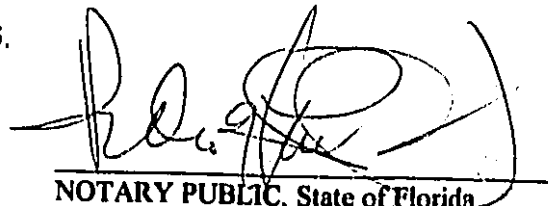
