I, the undersigned natural person competent to contract acting as incorporator of a corporation for profit under the General Corporation Law of the State of Florida, do hereby make, subscribe, acknowledge and file the following Articles of Incorporation for such corporation.

ARTICLE I

ARTICLE II GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted is:

To engage in any activity or business permitted under the laws of the United States and of the State of Florida, and any other jurisdictionwherein it may conduct business..
