

SECTION 1.01 NAME:

The name of the incorporation is:

SECTION 2.01 CAPITAL STOCK AND INITIAL CAPITAL:

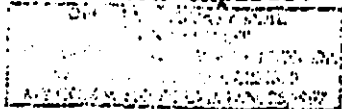
