ARTICLES OF INCORPORATION
OF
INSECT-E-CUTER, INC.

The undersigned natural persons, residents of the State of Florida, hereby associate themselves with the intention of forming a professional corporation and hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is Insect-E-Cuter, Inc.

ARTICLE II - DURATION

The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholders as provided in the by-laws.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in the practice of pest control and extermination. That incorporator, Garry L. Catura, is licensed to engage in the profession of pest control and extermination in the State of Florida.

ARTICLE IV - CAPITOL STOCK

The total number of shares of capitol stock which the corporation shall be authorized to issue is 100 shares. Such shares shall be of a single class of common stock, and shall have a par value of \$1.00 per share.

ARTICLE V - CAPITALIZATION

The amount of capitol with which the corporation will begin to practice the profession of pest control is not less than \$5,000.00.

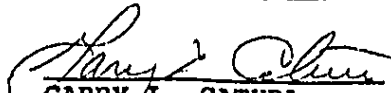

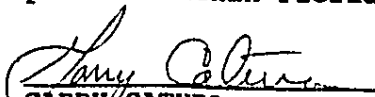
