ARTICLES OF INCORPORATION OF IRC MINISTRY FOR CHILDREN, INC.

ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be the IRC Ministry for Children, Inc. The principal and mailing address of the corporation shall be 14009 Ridgedale Way, Tampa, Florida 33625

ARTICLE II - DURATION

The Corporation shall have perpetual duration.

ARTICLE III - PURPOSES

The purpose for which the corporation is organized includes the following: implement programs and curriculum for children for use by businesses and individuals, including, but not limited to, day care centers, pre-schools, and churches and for providing other services as may be authorized by law.
