ARTICLES OF INCORPORATION

OP

CHARLES DANIEL SIKES, P.A.

The undersigned incorporator to these Articles of Incorporation, being an Attorney duly licensed to render services as such under the laws of the State of Florida, hereby forms a corporation under the laws of the Professional Service Corporation Act and the laws of the State of Florida as follows:

ARTICLE I

NAME OF CORPORATION

The name of this corporation is CHARLES DANIEL SIKES, P.A.

ARTICLE II

TERM OF EXISTENCE

The date when corporate existence shall commence shall be the date of filing of these Articles of Incorporation by the office of the Secretary of State of the State of Florida and the corporation shall have perpetual existence thereafter.

ARTICLE III

GENERAL NATURE OF BUSINESS

This corporation is organized for the following purposes:

A. To engage in every phase and aspect of the business of rendering the same professional services to the public

that an Attorney duly licensed under the laws of the State of Florida is authorized to render.

B. To engage in any and all other lawful business activities authorized by Chapter 621, Florida Statutes.

ARTICLE IV:

POWERS

The corporation shall have power to:

- A. Invest the funds of the corporation in real estate, mortgages, stocks, bonds or any other type of investments, and to own and lease real and personal property necessary for the rendering of such professional services.
- B. To do anything necessary and proper for the accomplishment or futherance of any of the purposes or objectives of this corporation enumerated in these Articles of Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of this corporation, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment or furtherance of such purposes or objectives of the corporation.

ARTICLE V:

CAPITAL STOCK

A. This corporation is authorized to issue One Hundred (100) shares of \$10.00 par value common stock, which shall be

designated Common Shares. The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than five (5) persons.

B. The corporation shall have the right to increase its capital stock either with or without par value in an amendment to its Articles of Incorporation.

ARTICLE VI

INITIAL REGISTERED OPPICE AND AGENT & PRINCIPAL ADDRESS

The street address of the initial registered office of this corporation in the State of Florida will be 486 North Temple Avenue, Starke, Florida 32091, and the name of its initial registered agent at such address is Charles Daniel Sikes.

ARTICLE VII

DIRECTORS

The corporation shall have one director initially. The number of directors may be increased or diminished from time to time by bylaws of the corporation, provided that the corporation shall always have at least one director. SHAREHOLDERS

Shares of this corporation's capital stock shall be issued only to individuals duly licensed to render services as Attorneys under the laws of the State of Florida. No shareholder of this corporation may sell or transfer his or her shares of stock therein except to another individual who is eligible to be a shareholder of this corporation.

ARTICLE X

INDEMNIFICATION

The corporation shall indemnify to the full extent permitted by law any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil,

criminal, administrative or investigative by reason of the fact that he or she is or was a director, officer, employee or agent of the corporation, against expenses (including attorneys' fees), judgments, fines and amounts paid in connection with such action, suit or proceeding. Such right of indemnification shall not be deemed exclusive of any other rights to which such director or officer may be entitled, under the bylaw, agreement, vote of shareholders or otherwise.

ARTICLE XI

BYLAWS

The directors of this corporation shall have the sole power to establish, enact, alter or repeal bylaws for the management of this corporation.

ARTICLE XII

REMOVAL OF DIRECTORS

The shareholders of this corporation shall be entitled to remove any director from office at any time for any reason whatsoever, whether or not there is cause for removal.

ARTICLE XIII

AMENDMENT
