WE THE UNDERSIGNED, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the provisions of the Florida Statutes, 1963, as amended:

DO HEREBY CERTIFY as follows:

FIRST:

The name of this corporation is BRADBURY, INC.

SECOND:

The nature of the business of the corporation and the objects or purposes proposed to be transacted, promoted or carried on by it, are as follows, to-wit:

Section A: To engage in construction of all types including but not limited to residential and commercial buildings.
