

ARTICLES OF INCORPORATION
OF

The undersigned incorporator of a corporation under Florida law adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is FLORIDA SITEWORK, INC.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - PURPOSE

The purpose of the corporation is the transaction of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV - CAPITAL STOCK

The corporation shall have authority to issue one hundred (100) shares of one dollar (\$1.00) per share par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

No preemptive rights shall be granted to shareholders.

**ARTICLE VI - INITIAL REGISTERED

ARTICLE VII - INITIAL BOARD OF DIRECTORS
