The undersigned incorporator of a corporation under Florida law adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is FLORIDA SITEWORK, INC.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - PURPOSE
