We, the undersigned, whose names are hereunto subscribed, make this ARY OF STATE certificate for the purpose of forming a corporation to be known as the HASSEE, FLORIDA Pharmaceutical Research Institute of America, Inc., and hereby associate ourselves together for the purpose of becoming such corporation for profit under the laws of the State of Florida for the purpose and with the rights, powers and objects hereinafter set forth, as follows:

### Article I

The name of the corporation shall be Pharmaceutical Research Institute of America. Inc.

## Article II
